## 课程简介

本课程是为北京大学国家发展研究院研究生开设的选修课。“法律经济学”是从 1950 年代起在美国以芝加哥大学的经济系和法学院为中心兴起的一门交叉学科。它以价格理论为分析工具，将英美各个分立的部门法以及形形色色的政府管制现象，纳入其深入剖析的视野，以探索这些法律与管制现象内在的相关逻辑，并为法律和政策的制定和实施提供理论和实证的依据。

本课程力图通过阅读经典和研究设计，将“法律经济学”的方法论基础与前沿实践运用紧密地结合起来，从而帮助学生在扎实掌握“法律经济学”的核心思想的同时，创造性地探索可将上述研究角度和方法付诸实践的课题，从而转入以问题为导向的深度阅读和实证研究的轨道上去。
