## **Analyst Program Description**

**Responsibilities:** The China-based Analyst Program gives qualified candidates broad exposure to global investment banking. Analysts work on a variety of assignments, often simultaneously, ranging from business development presentations to equity and debt offerings, mergers, acquisitions and divestitures, and real estate financing throughout the Asia Pacific region, with an emphasis on China. Analysts receive a broad-based introduction to financial analysis and exposure to a variety of business scenarios and financial products. Responsibilities will include analyzing financial and operating information, creating statistical exhibits, building and using computer spreadsheet models, developing marketing memoranda, participating actively in the execution of financings or M&A transactions and contributing to team discussions and client meetings.

Our China-based Analyst program offers Analysts in Beijing or Shanghai an opportunity to work on a full range of business development and execution experiences with an emphasis on transactions in China. As part of the program, the Firm also provides an opportunity to undertake an approximately 6-month rotation through the Hong Kong office (housing provided) in order to provide broader exposure to professionals and our business throughout the Asia-Pacific region. Although the program traditionally has a one-year term, top performing Analysts may be considered for a second year and a third year (Senior Analyst) in Investment Banking. Outstanding Senior Analysts may be offered the Accelerated Career Path (ACP) program that directly promotes them into Associate-level positions.
